They appreciate being able to support all that RMHC does to help families stay close to their children who are receiving life-saving treatments at nearby hospitals.”

Katahdin Trust employees can dress casually on the second Friday of each month in support of various non-profit organizations throughout Maine. Each employee that participates in Casual Because We Care Days donates a minimum of \$1 in exchange for the privilege to dress casually and wear jeans. Proceeds are sent quarterly to a pre-selected non-profit organization.

Last year, 7,595 nights were provided to 652 families with 12 nights as the average length of stay. The cost of a family’s one-night stay at the House is \$75; however, families are asked to contribute only \$10 per night towards their stay. Over 74% of those families were unable to contribute due to mounting medical bills. No family is turned away due to inability to pay, ever.
